#### AUDIT EXECUTIVE SUMMARY:

The operation mixes and packs bird food blends which are comprised of grains, dried fruit, and it repacks grains, nuts and seeds intended for animal/bird feed for a few clients. These are made for specific customers. The operation also re-packages a spice blend that is sold to another operation and is ultimately intended for human food as part of a rice mix. Repackaging of the spice blend occurs for approximately one week every three months. Mixing of the bird seed blends and repacking of the grains, seeds, and nuts occurs on an ongoing basis. All lines are dry packing/mixing lines, and the facility is kept at ambient temperature. Soy, walnuts, and tree nuts are allergens that are present in the facility and these are handled at the end of the day, and allergen swabbing is done to confirm efficacy of cleaning procedures. The facility is 15,000 square feet in total and has 4 packing line, 2 of which were operational at the time of the inspection. All water used in the facility is from the municipality.
